(a) it demonstrates important aspects of the evolution or pattern of the State's history	From the perspective of white settlement, Australia is a young country. Decisions made today will have ramifications into the future with regard to what aspects of our history are preserved. Port Adelaide is an important part of South Australia's foundation story. The buildings that are preserved now will help future generations better understand how the Port functioned and how ordinary people contributed to the State as it grew. Shed 26 has a striking vantage point on the Port. It is especially important because it sits along from the Newport development that was such a disappointment to the locals of the Port and the Peninsula. To lose Shed 26 would be to lose an opportunity to preserve a prominent feature of the Port and use the building for multiple purposes that can enhance the overall built environment now as well as be a link to history. This preservation could have benefits to the people who buy into the new development as well – adding substantially to the interest of the area and reducing the potential for the development to be more soulless and boring
